First it is God's gift to those families that have one of these girls (it only affects girls), it is non hereditary and is a defect on the Mecp 2 protein.

The symptoms are: Seizuring 15-20 times a day (80% of the girls), constipation, their in the bottom 10% of hand, head, and feet size. Many of these children do not walk. Scoliosis is very common before age five,

they are non verbal and all of these girls have some kind of regreition by age five.

I can not say enough good things about my wife! When we found out that Catherine had Retts our Doctor told Heidi that she would be dead by the time she was 15 years old. Heidi, went on a mission from that point and started researching first what is Retts, then what can we do to stop the regression faze of the disease. By the way Heidi let the Doctor have it when we found out that many of these kids live long lives.

We are in two National studies, the first is at John Hopkins, the

second is Alabama Birmingham.

What Catherine's condition has done is forced us to challenge our belief if Shaklee is the best company out there or is there something better?

Catherine is a healthy seven year old right now and ranks for her age against all children of her age in the following:

Weight 87%

Height 77%

BMI 85.6% this is

unheard of in Retts.

In hands, head and feet size she is above 80% usually these appendages are cold to the touch. Catherine's are always warm. The doctors are puzzled that this does not happen with a Retts child. Catherine has not gone through a regression part of Retts. She shows no signs of Scoliosis and is able to walk up stairs and ride a bike without being strapped in. Doctor Percy who has seen 400 of the 600 known

cases in the United States says she is at the top as far as what she can do. He still does not understand this do to where Catherine's mutation is located. We do give Catherine a lot of food supplementation. But when you weigh the choices of everything that Catherine should be and is not what a small price to pay! After our six month follow up in Chicago (Alabama Birmingham Study) Doctor Percy who runs the Study said Catherine was the only Retts child to increase in her size rank from one check up to the next. All of these children decrease in rank as time goes on.

Doctor Rodriquez is a pediatrics child nutritionist that set up a program for

following on a daily basis and we divide it up during each of her meals.

International Arctic Project - 1995 this was the first official dietary study of arctic explorers who were supported by Shaklee nutrition. In this dogsled expedition, Will Steger's team was the first to cross the Arctic from Russia to Canada via the North Pole in a single season. This was a 3 month, 1,000 mile trip.

Jacques Cousteau – Cousteau Society: Cousteau chose Shaklee's safe, biodegradable, non toxic, effective cleaning products for his high tech research vessels, Calypso and Alcyone, to ensure that no harm would be done to the environment he so loved. **Over 50 Gold Medalist, the last three Olympics.**

Do your homework, become educated, prove it to yourself? Try this, mail the following sample of questions to your current supplement supplier and or any companies you may be interested in. See what type of response you receive. A reputable and credible company should be willing and able to answer any and all questions you have.

1. How much has been spent of scientific (not marketing) research to date?
2. How long has the company been in business?
3. How many full time research staff does the company employ?
4. Do independent research scientists evaluate new product concepts? If so, who?
5. Does the company have a medical advisory board? If so, who is on it?
6. Do all product label claims have proven and documented substantiation?
7. **Has disintegration time of nutritional supplements been tested? Are all nutrients proven bio available to the cells?**
8. What colors, flavors, preservatives or fillers does your product contain?
9. Is the product whole food sourced?
10. Are ingredients organically and non- GMO sourced?
11. Are products processed using high heat? Do they have proven enzymatic activity?
12. What quality controls are placed on raw materials?
13. What quality controls are in place for product stability during the manufacturing process (ex. Temperature and humidity)?
14. What quality assurance tests are run throughout the manufacturing process?
15. Is clinical testing done on the finished product?
16. Is a 100% money back guarantee offered on your product?
17. Please send a complete bibliography of all research that has been accepted for publication in refereed or peer reviewed professional journals. Is the published research done by scientists employed by your company or those on your advisory board? Is it done on the specific products being manufactured by your company?
